Know the facts

1 in 10 men 1 in 4 children

have committed sexual offences against children (Human Rights **Commission, November** 2023)

have been sexually abused and 1 in 10 in care outside the home (Abel et al., 2019)





Know the facts...

Police reports reveal that in Australian females perpetrate 1% to 6% of all reported Child Sexual Abuse (CSA) and 5% to 31% of all female perpetrated CSA occurs in an organisational setting whilst caring for children. (Child Wise, 2006)



Know the facts...



- Only 35% of cases involve immediate staff.
 Predators could be in any number of positions: carers, directors, family of carers/directors, bus drivers, just to name a few and they could be male or female and work alone or with others (Finkelhor et el, 1988, Kelley et al 1993).
- Abuse could occur anywhere in the centre with one study finding only 66% occuring in the bathrooms (Finkelhor et al., 1988).



Disturbingly, each child abuse case in a center or by non-family member tends to involve an average of 4.4 instances of sexual abuse

66% female and 34% male victims










Know the facts

Mother questions how childcare abuse accused was allowed to keep working Brisbane Times, October 25 2023 Dan Nolan

April 2022 Kym's daughter told her mother at bedtime that "Ashley touched my privates". "My heart sank but I said 'who is Ashley?' and she said 'the man teacher' or 'the boy teacher'," Kym said.

She also notified Queensland police, who conducted an interview with the child. That interview was conducted without any parent or support person in the room, as per Queensland police guidelines.

"She was hesitant, of course, she'd never met these people before. It took us a while to warm her up to want to be in the room without us," Kym said. She said her daughter repeated her claims but became confused when she was given a teddy bear to show where he

had allegedly touched her. Police determined there was not enough evidence to continue the investigation."The detective did say to me afterwards, 'I've been doing this for a really long time, I deal with a lot of children who have been interfered with and your daughter doesn't seem like a child who has been interfered with'," Kym said.

The investigation was handled by the Child Protection and Investigation Unit at the Boondall police station, which had also investigated a previous complaint against Griffith about six months earlier.

That October 2021 report came from a childcare teacher who alleged she had seen Griffith kiss a young girl whilst sleeping. It had occurred at a different Brisbane childcare centre, run by the Uniting Church, which was also dismissed by police.

Police were unable to secure a search warrant for Griffith's devices, claiming the report it received did not involve "physical contact".

When Australian Federal Police officers arrested Griffith in August 2022, he was working at a Gold Coast childcare centre and 4000 images of child abuse material were discovered on his phone and other devices.

It was only after new Queensland laws unmasking accused sex offenders came into effect three weeks ago that Kym discovered the teacher her daughter complained about was the same man accused of being Australia's worst paedophile.

A Queensland police spokesperson confirmed that Griffith was not interviewed by detectives about the second complaint in April 2022 because the alleged victim "did not make disclosures of an offence to police".

"Additionally, childcare centre staff and management informed police, the man was never left unsupervised with children and the offence could not have happened," the spokesperson said.


As parents and as a community

Prepare an anonymous facebook post listing signs of sexual abuse in children at local daycare and your concerns directing people to go straight to the police or local hospital

Avoid defamation* and use the term allegations, do not name the centre or Perpetrator

• Write a letter to your local minister and shadow minister for health and police. • Make anonymous media presentations, identities of victims must be hidden. Contact the larger media stations.

Questions to ask your daycare centre?

1. Do they have a child protection policy? (does it define signs of sexual abuse)

2. What child protection training do the staff/volunteers and parents receive?

3. Do they have cameras in play areas and change areas?

4. Are there areas at staff?

5. Have you ever had an incident or complaint of suspected or confirmed sexual abuse?

6. What do they identify as the most vulnerable areas in the centre for sexual abuse or the most likely perpetrators and how do they manage it? (check to see if they provide answers beyond change tables and carers)



4. Are there areas at the centre that are not visible to other



The types of sexually abusive acts committed in day care

- rectal intercourse.
- Penetration with a foreign object to be more prevalent among female perpetrators, especially in cases with multiple perpetrators
- Foreign objects include pencils, needles, knives, scissors and crucifixes

In some cases daycare aged children are shown/told about wands, swords & knives during penetration with another object to distort and discredit child disclosures.

Threats of death and harm were used frequently "something very bad will happen to you or you family if you tell." Threatened harm from monsters, snakes, demons and spiders. Harming animals to create fear.



Sexual Abuse Signs (<11yrs)

- Kegression in sleep (wake ups, needing parents to sleep)
- Increase in anxiety or fears, emotional outbursts, tantrums
- Sore red/chafed genitals, bleeding from private parts
- **V** Playing with genitals
- Complaining of sore genitals, or that someone has stuck something in their genitals
- **Vnexplained bruises**
- Sexualised behaviour
- Sexualised play with dolls (only 2% false disclosure rate with dolls Emerson and Boat 1990)

Responding to suspicions of abuse

A child or young person's behavior and words may show signs of potential harm or unsafety.

- Avoid frightening them by refraining from confrontational or leading questions.
- Initiate a conversation using prompts such as 'I'm noticing' or 'Are you x..?'
- Reassure the child that you are available to talk whenever they need support.
- Document your concerns, including behavioral observations and conversations.
- Fulfill your obligations by reporting to relevant authorities as soon as practically possible.
